MATTERS ON THE AGENDA: If you wish to address the Planning Commission on a matter on the agenda, please wait until the Chair opens the public hearing or calls for public comment on that matter. For public hearings and appeals, the applicant is invited to speak first, followed by those who support the project, then those who have concerns or oppose the project. The applicant is then given the opportunity to rebut. Appellants will be afforded the same opportunities as applicants.

AGENDA ITEMS: The Agenda contains the regular order of business of the Planning Commission. Items on the Agenda have generally been reviewed and investigated by the City Staff in advance of the meeting so that the Planning Commission can be fully informed about a matter before making its decision.

PH-1 [Tentative Tract Map TTM2019-82659, Conditional Use Permit CUP2019-0006, and Minor Exception ME2019-0010](#)
425 West Duarte Road; Applicant, Justin P.J. Kao

Request: Construct a 6-unit, two-and-three-story, attached townhouse development in the RH (Residential High Density) zone. Allow the east property line wall to exceed the maximum permitted height (7' in lieu of 6') and encroach up to 5' into the required front yard setback at that height. Determine that the project is Categorically Exempt (Class3) from the California Environmental Quality Act (CEQA).

Recommendation: Recommend Approval to the City Council of Tentative Tract Map TTM2019-82659, Conditional Use Permit CUP2019-0006, and Minor Exception ME2019-0010

PH-2 [Conditional Use Permit CUP2019-0004 and General Plan Conformity GPC2019-0001](#)
518 East Olive Avenue; Applicant, Alberto Cisneros

Request: Construct three (3), two-story, detached residential units in the RM2500 (Residential Medium Density) zone and find that a proposed two foot wide easement along the Gladys Avenue frontage conforms to the provisions of the Monrovia General Plan. Determine that the project is Categorically Exempt (Class 3) from the California Environmental Quality Act (CEQA).

Recommendation: Find that the proposed easement is in conformity with the General Plan and approve CUP2019-0004.
